

1. **Our waitlist system shows VERY CLEARLY what items should be taken into account when adding applicants to waitlists.**
2. **This is important** because the same person may be on many waitlists, but not be in the same *position* on each list because each properties' **Tenant Selection Plan** may stipulate different income requirements, priorities, or unique eligibility requirements.
